Treasurers Report

2021 was another odd year. The JAD Board started the year with a projected budget of \$11,840 in the negative. With projected expenses for the remainder of the year, I estimate that we will end up around \$2,000 in the positive. We have upcoming expenses for the Winter Board Meeting, however we will have revenue from interest income, BHS monthly charitable donations, as well as registrations for Top Gun (assuming this program is able to move forward). The Board currently has approximately \$94,000 in its checking account, as well as an additional \$32,700 in CDs. We look forward to 2022 and hope to provide move closer to normalcy and will seek to wisely use your funds to provide the best programs possible.

- President Foisy Called to Order at 10:30 am
- CC Snyder reviewed Zoom meeting logistics
- Past President Rubin opened with group singing The Old Songs
- President Foisy introduced the list of officers and directors
- Acknowledgement of DPs and Guests
 - o David Rubin, Bari Courts
- Secretary's report:
 - o Roll Call
 - Doc George move we continue with the meeting with 20 present due to Covid situation, approved by acclimation
 - Approved the meeting agenda
 - Approved previous minutes
- President's minute
 - District is looking forward to resuming to normal in second half of 2021. Summer Shindig Parade of Quartets along with any chapters
 - o Planning full fall convention in Dayton
 - Chapters are starting to return to in-person meetings, discussion of attending representatives regarding how their chapters are restarting, a variety of plans were discussed
- Treasurer's Report Chad Lulfs
 - o Update to report distributed, \$6300 under budget at this point.
 - Received the Harmony Foundation check
 - Dues are down this year, hope to see increase when chapters reopen and fall convention is held
 - Motion to accept Treasurers report, seconded and passed by acclimation
 - 2021 Budget provided in the Apple Orchard.
 - Support for judge candidates has been added, along with replacement of convention laptop
 - Adjusted deficit of \$11,840 due to lack of Spring Convention, drop in member dues and providing programs to members with no additional fees.
 - Request for spreadsheet format to be provided to delegates, along with past expenses to compare.
 - Some members have not been receiving notice of memberships expiring, may be because of inaccurate emails, etc.
 - Discount dues categories have changed, members are frustrated with lack of communication provided by Society
 - Motion to approve budget, seconded and approved by acclimation
- Consent Agenda: Acceptance of the written reports
 - Motion to approve written reports as provided in Apple Orchard, seconded and approved by acclimation
- Planned Events (Nathan Miller)
 - Reviewed upcoming events
 - Summer Shindig, Saturday July 23, outdoor event, free to members, will also be livestreamed, more details to come as contracts are signed.
 - IQT Training in Columbus, August 21st. Doug Smeltz will be managing.

- Quartet Video event on August 21st for interested quartets.
- Joint Fall Convention with Cardinal District, in Dayton. Plan to have at least 20 non-contest events included with the contest events. It will be streamed with a small fee. District Quartet Championship, qualification for Choruses to qualify for Charlotte 2022 International Contest. Champions will be selected for each district.
- JAD Leadership Academy will be held in Columbus in January 2022, details to be provided
- The schedule of events is posted on District Website, along with Facebook page. It will be emailed to Chapter leaders also for distribution to members.
- Open discussion around Covid rehearsals, keeping members engaged, staying safe, etc.
 - The District is not providing guidelines for the chapters and recommends following national, state and local regulations. There is no current plan to require evidence of vaccinations to participate
 - CDC has recently provided guidelines regarding indoor singing with masks and spacing, with fully vaccinated participation. Most recent CDC guidelines:https://www.cdc.gov/coronavirus/2019-ncov/daily-life-coping/participate-in-activities.html
 - Chapters should follow guidelines of their respective health department.

 - Matt Hopper, Harmony Foundation Intl representative to JAD, reviewed HFI disbursement to the District, along with 32 chapters receiving Donors Choice disbursements. He is available to attend Chapter meetings, in person or zoom to discuss disbursements, etc.

Director of Administrative Leadership Report

Leadership Academy 2022

At the time of this report's submission, the Leadership Academy for 2022 is still scheduled for an in-person event. However, a number of other BHS/District-related events have been cancelled or modified in favor of a virtual or quasi-virtual event. The JAD Board has recently discussed the possibility of another Virtual Leadership Academy in 2022, and, at this point, we are on hold until we can examine the COVID environment in early October.

Many plans have already been made and sessions booked for an in-person event, should we be allowed to deliver one, but we will hold off on those announcements and, of course, opening registration until we know for sure what type of event we will be holding. It is likely, by the time this report is received by members of the House of Delegates, the decision will have already been made.

While a Virtual Leadership Academy is certainly not our preferred method of conducting these learning sessions, we are fortunate in the fact that this would not be our first foray into the world of virtual events. This past January, as the Spring Report indicates, we delivered a successful Virtual Leadership Academy. That report contains all the details concerning total attendance, evaluations of sessions, and any technology problems we had during that initial effort in the virtual world for this event.

Should we be forced to go with a second virtual event, we will do everything we can to make sure the sessions are relevant and well-delivered and that attendees will, once again, provide very positive feedback on the experience. We also will do everything we can to learn from our experience and avoid letting technology hamper our efforts to get everyone registered and "present" when the sessions begin.
